**a. Google Hangouts Meet meeting login instructions:**

ii. For mobile devices (tablets and iPhones/smartphones):

1. Please go to either 'Google Play' [Android] or the iOS 'App Store' [iPhones and iPads] and download the free program 'Google Meet.'
2. Allow the program to access your device's camera and microphone.
3. Then click 'Enter a meeting code' and type in 'myv-cmko-hit.' Then click 'Ask to join.'  
A facilitator will enable you to enter the meeting.

**b. Telephone: For standard telephones and cell phones:**

1. Dial the number 1 650-597-0302.
2. When prompted, enter the PIN: 460 056 009□#. A facilitator will enable you to enter the meeting.
