Members of the public will be allowed to make comments during the portion of the meeting that is designated for public comment, by typing comments into the Chat function and/or by speaking into the telephone or computer microphone when recognized by the Chair.
 - a. **Google Hangouts Meet meeting login instructions:**
 - i. For computers, browse to the following web address: meet.google.com/egy-pwdj-tcn
 - ii. For mobile devices (tablets and iPhones/smartphones):
 1. Please go to either 'Google Play' [Android] or the iOS 'App Store' [iPhones and iPads] and download the free program 'Google Meet.'
 2. Allow the program to access your device's camera and microphone.
 3. Then click 'Enter a meeting code' and type in 'egy-pwdj-tcn.' Then click 'Ask to join.' A facilitator will enable you to enter the meeting.
 - b. **Telephone: For standard telephones and cell phones:**
 1. Dial the number 1 337-451-1295.
 2. When prompted, enter the PIN: 382 252 041□#. A facilitator will enable you to enter the meeting.
2. Individuals appearing before the Open Space and Recreation Committee must make arrangements to present remotely as there is no physical meeting location.
