VIOLATIONS AND ACTION TAKEN ON VIOLATIONS FOR 2013

April 11, 2013

La Fiesta, Inc. dba Anchor Pub and Grill: sale of alcohol to a minor, three day suspension to be served within one month. Licensee appealed decision to ABCC, hearing was set for November 20, 2013. Licensee withdraw request for ABCC hearing on 11/15/13. Suspension served on 12/2, 12/9 and 12/10/2013.

May 9, 2013

Italian Community Center, Inc.: violation of "Club" license status by opening bar to public and non-members. Three day suspension served within one month.
